ORDER:-

Orders were issued in the G.O.1st read above, framing fresh rules for the conduct of Education Common Entrance Test for admission into B.Ed Course in accordance with National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2014.

2. In the G.O.2nd read above, amendments have been issued to the orders issued in the G.O 1st read above.

3. The Secretary, Telangana State Council of Higher Education, Hyderabad in his letter 3rd read above, has stated that the TS Ed.CET-2021 Test Committee constituted to conduct TS Ed.CET-2021 for admission into 2-year B.Ed Course for the Academic Year 2021-2022, in its 1st meeting held on 27.02.2021 proposed certain amendments to the said rules for conduct of Ed.CET-2021 to change the eligibility criteria from the academic year 2021-2022 onwards.

4. The Government after careful examination of the proposal of the Secretary, Telangana State Council of Higher Education, Hyderabad, hereby decided to issue amendments to the Telangana Conduct of Education Common Entrance Test for admission into 2-year B.Ed Course Rules, 2017 issued in the G.O.1st read above.

5. Accordingly, the following notification shall be published in the Telangana Gazette, dated.12.04.2021.

NOTIFICATION

In exercise of the powers conferred by sections 3 and 15 of the Telangana Educational Institutions (Regulation of Admissions and Prohibition of Capitation Fee) Act, 1983, (Act No.5 of 1983) the Government of Telangana hereby makes the following amendments to the Telangana Conduct of Education Common Entrance Test for admission into 2-year B.Ed Course Rules, 2017 issued in G.O.Ms.No.13, School Education (Training) Department, dated.27.05.2017 and as amended subsequently from time to time.

AMENDMENTS

In the said rules,

1. In rule 3, in Sub-rule (iii), for clauses (a) and (b), the following shall be substituted, namely:-
“(a) In any Bachelors Degree i.e. B.A, B.Com, B.Sc, B.Sc (Home Science), BCA, BBM, B.A (Oriental Languages), BBA or in the Masters Degree, securing at least 50% aggregate marks.

- (b) Bachelors in Engineering or Technology with 50% aggregate marks or any other qualification equivalent thereto”.
2. In rule 4, (a) in Sub-rule (vii), for clause (a) and the table thereunder, the following shall be substituted, namely:-
- “(a) Ed.CET shall be conducted to take admissions in the following Methodologies:-
- (i) as per the percentage of seats earmarked under Table-I;
and
- (ii) as per eligibility criteria as shown under Table-II below to enable the eligible and qualified candidates from the test for admission into 2-year B.Ed Course.

TABLE –I

Methodologies and percentage of seats:-

S.No. (1)	Methodology (2)	Percentage of Seats (3)
1	Mathematics	25%
2	Physical Sciences	30% interchangeable keeping 10% of the seats minimum and 20% of seats maximum in each Methodology.
3	Biological Sciences	
4	Social Sciences	45% interchangeable keeping 5% of the seats minimum in English Methodology and 5% of seats minimum in Oriental Languages Methodology and 15% of seats maximum put together in English and Oriental Languages Methodologies.

Methodology-wise Eligibility:-

SL No. (1)	Methodology (2)	Eligibility (3)
1.	Mathematics	Candidates with B.A/B.Sc with Mathematics as one of the group subjects, B.E/B.Tech with Mathematics and BCA candidates with Mathematics at Intermediate level as a group subject.
2.	Physical Sciences	Candidates with B.Sc who have studied Physics or Chemistry or allied subjects under Part-II group subjects. B.E/B.Tech with Physics or Chemistry subjects and BCA candidates with Physical Sciences (Physics and Chemistry) at Intermediate level as group subject.
3.	Biological Sciences	Candidates with B.Sc./B.Sc (Home Science) who have studied Botany or Zoology or allied subjects under Part-II group subjects and BCA students with Biological Sciences at Intermediate level as group subject.
4.	Social Sciences	All Candidates with B.A with Social Science subjects/B.Com/B.B.M/B.B.A and BCA students with Social Sciences at Intermediate level as group subject.

5.	English	The candidates with B.A in Special English/English Literature/MA English.
6.	Oriental Languages	Candidates with B.A Telugu/Hindi/ Marathi/ Urdu/Arabic/Sanskrit as one of the optional. Candidates with Literature (BA-L) (Telugu/ Hindi/ Marathi/ Urdu/ Arabic/ Sanskrit). Candidates with BA (Oriental Languages) in Telugu/ Hindi/ Marathi/ Urdu/ Arabic/ Sanskrit. Candidates with Master's Degree in Telugu /Hindi/ Marathi/ Urdu/ Arabic/ Sanskrit."

(b) for sub-rule (viii), the following shall be substituted, namely:-

“(viii) The candidates who have obtained qualifying marks in the Entrance Test shall be assigned ranking in the order of the merit on the basis of aggregate marks obtained in the Entrance Test.”
